- I. Call meeting to order at 6:31pm
- II. Agenda-additions-Approval of Agenda & April meeting minutes.
- III. Watershed District Projects update / Discussion topics:
 - a. Carp contest results. Carp seining outlook.
 - i. 6am Sunday, results came in-
 - 1. 13 teams; Killin' Time had 62 fish!
 - 2. Chase-n-Scales had 30 fish
 - 3. Force Fed had 3rd largest
 - 4. Back County Bow Fishin had the smallest
 - 5. 25.3 pounds was the largest caught
 - ii. Only 12 carp from Cedar Lake's Carp Kabob Tournament
 - iii. Thane Tandy at Knotty Oar indicated he would like to do this again next year.
 - iv. Thane may still want to host next year even if the Watershed reduces or changes any contributions.
 - v. Comparing seining with contest; the prize money was \$2100; seining costs \$5k and yielded more than the carp contest. Which is the best visibility and carp removed?
 - b. Bog on Spring Lake was handled by the Sherriff and taken to the appropriate area of the lake.
 - c. Low flow outlet gate management plan update and Spring Lake dam
 - i. Has been open since 4/25/17
 - ii. Some analysis now low flow gate only works best when the water level is at a certain level.
 - iii. Working with the DNR on dropping low flow gate to 902.5- but not preventing its use.
 - iv. City, the District and Spring Lake Twnp sat down to make sure everyone is on the same page regarding damming up the Spring Lake Outlet.
 - v. The City is putting their "enhanced protection plan" together—it is called the "Flood Response Policy."
 - vi. Signs are out now to indicate that the water is high and a slow wake is good (SOS).
 - vii. The City is checking on sand donations.
 - viii. The City closed the Little Prior outlet closed.

- ix. 903.9 Prior Lake 912.8 on Spring Lake.
- x. Prior Lake currently at 903.44 may be a good time to do a dam on Spring Lake to Prior Lake soon- Modeling is being done with the District's engineer.
- xi. Letters ready for Spring Lake, other communications ready as well.
- xii. Volume 68 cfs entering Prior Lake. 50 cfs leaving.
- xiii. Outlet channel repair is going through the permitting process. Have until July of 2018 to get the permitting done.
- xiv. A few areas one can 'see' the water moving down the channel (outside of the pipe).
- d. Clean Water: Governors town hall meetings.
 - i. Burnsville Oct. 4. Other meetings quite a few but Burnsville is closest to Prior Lake.
- e. DNR request, catch and release to create a better fishery.
 - i. Make PL, SL a catch and release to create a better fishery.
 - ii. Fishing is part of the use of the lake—
 - iii. Seining last time on Spring Lake had good trophy fish so why do the catch-n-release?
 - iv. Can a lake association buy stock? If so, a permit would still be required.
 - v. IS the DNR doing enough to manage our lakes?
 - vi. More game fish will keep down the carp minnows. This should be a clean water strategy.
- f. Managers meeting WSB carp management project video.
 - i. Video viewed for this item.
 - ii. Nice to have the 3 barriers
 - iii. Info from the barrier tracking- not yet available.
- g. Fish Point Park Party is on Tuesday June 20
 - i. There will be volunteers planting tomorrow on 5/26
 - ii. Would all schools in other cities around the area be interested? What about other establishments?
- h. Impervious surfaces, impact of 400 new homes N.E. Prior Lake.
 - i. No direct flow into the lake from new developments; will go into retention ponds
 - ii. No new technology for new building and impervious surfaces. May be better for existing construction where holding ponds are not possible.
 - iii. Planning starts with city staff before ending up at the planning commission.
- i. Carp removed from Spring Lake 2,527. Carp estimate in Upper Prior 7,622.
 - i. Carp barrier is planned for the area where Spring Lake enters into Upper Prior.
 - ii. Electro-fishing is best for tagging but not removal.
 - iii. Upper will be the focus since Spring Lake is low now.
 - iv. Arctic lake SMSC has hired a seiner for this lake.
- j. Steve sent the link to the Waconia storm water resale.
 - i. Boudin's park has something under the ground that was put in place to hold water.
 - ii. SMSC may be working on a project to recycle 'grey' water.
- k. Scott County applied for a grant to do aquatic inspections on Spring Lake and Prior Lake to inspect boats at the landings. So staffing at the launch sites will be staffed.
 - i. Diane will check to see if these people could let boaters know if/when we go into a no wake stage.
- I. Spring Lake Alum- need to wait for test results from Three Rivers.
 - i. Jamie is working on an Alum matrix and will present a revision at the June meeting.
- m. Street sweeping is in full force.
- n. Raymond Park when will volunteers be sought
 - i. Only doing a seeding now...
 - ii. Spring Lake picnic cannot be held there this year.
- o. Lakefront Days this year- need volunteers!
