Lake Assignment: Each boat will be restricted to a single lake. There will be no more than 10 on Spring Lake and 40 on Prior (Upper or Lower). Boats will be assigned to lakes according to their indicated preference on a first-come, first-served basis. Entries received after all lakes have reached their boat quota will be put on a waiting list, and have their entry fees returned after the event.

2-Lake Carp Tournament Entry

Prior Lake – Spring Lake

All participants will be required to complete and sign the following release **at the event** (photo identification required), waiver and assumption of risk before engaging in the 2-Lake Carp Tournament (the Event). Participation involves boating, bow fishing and other activities on and near water.

Assumption of Risk: I understand that participating in this Event is potentially hazardous, and that I should not participate unless I am medically able. I assume all risks of participating in this Event, and I assume full responsibility for my conduct and actions, including any injury to myself or others or damage to property that may result while participating, and release the District and its representatives from all claims arising from injury or damage to the full extent permitted by law. Risks include, but are not limited to, drowning, slips, falls, equipment failure, injury from sharp equipment and improperly administered first aid. I recognize the District makes no representations whatsoever as to whether the venue for the Event is safe or as to whether the safety recommendations provided are comprehensive or adequate. I acknowledge these hazards and risks associated with participation in the Event and choose to assume them. I also agree to follow all MN DNR fishing and boating rules and regulations, and have reviewed and agreed to follow the Rules of the Tournament.

Photography and Publicity: I understand and acknowledge that the District reserves the right to photograph, videotape and otherwise record participants in the Event and to use sound and images of the participants for publicity purposes without further release or concurrence. Participants will not be compensated for use, playback, transmission or broadcast of such sound and/or images. I understand and acknowledge that my name and other identifying information also may be included in District communications.

By my signature, I affirm that I am 18 years of age or older and I have read, understand and accept all terms of this document and voluntarily agree to its terms as a condition of participating in the Event. This agreement may not be modified orally, and a waiver of any provision does not modify any other provision herein. I understand that I am relinquishing substantial legal rights, including certain rights to sue. Each team member must sign to participate. (Teams may submit application and payment with just the signature of the main contact, but all participants must sign form prior to launch.)

Parent or Guardian of a Minor: I, as parent or guardian of the below-named minor, give my permission for my child or ward to participate in the Event or accompany me as I participate, and further agree, individually and on behalf of my child or ward, to the terms above.
