- III. Additions to the agenda please ask Christian to include future items on the agenda prior to the meeting. They should be related to the CAC's goals for 2020.
- IV. 2020 Possible CAC Activity Areas –Goal is to have short updates at each CAC meeting and have some really good progress at the 3-month mark. CAC members should prepare a Fact Sheet on the topics and then review them with the CAC and request approval, prior to presenting it at a Board meeting.
  - a. Diane will provide CAC members with a Fact Sheet format that can be used to prep for presentations.
  - b. Shoreline Restoration (Water Quality) -Jodi is interested. She will reach out to see if maybe Liz would be interested.
    - i. How does the permitting work?
    - ii. What are the regulations; do they need to be updated?
    - iii. Who inspects the work when it is done?
    - iv. Are there new techniques to share?
    - v. Pete Young from the City may be a good source of information.
    - vi. Take the opportunity to educate what you can and/or should do
  - c. Fish Stocking (Water Quality & AIS) Steve and Christian are interested
    - i. Northern Pike Stocking
    - ii. Christian provided insight into some research he has done on local area lakes.
    - iii. Muskies is not the recommended fish to stock
    - iv. Currently Walleye is the fish used for stocking local lakes
    - v. How does the shoreline and the urban restoration impact the natural fish habitat?
    - vi. Each lake (Upper, Lower, and Spring) are each ecologically different and that should be considered separately
    - vii. If this moves forward into action, an article should be written and published in the PL American, on the Watershed website etc.
    - viii. Have the DNR come to discuss fisheries with the CAC and open the meeting to the public
    - ix. Bring it in as a 50thAnniversary item in 2020; make it part of our education outreach.
  - d. Storage Assessment, Plans and Wetland Banking (Storage)
    - i. Diane will provide copies of information provided at the October tour

- ii. Duck's unlimited wetland has good water quality
- iii. Land and easements will be needed for water storage
- iv. Any corporate farms in the watershed? Probably not.
- v. MPCA may have some programs, grants or loans.
- vi. Diane mentioned some past studies may provide benefit to the planning.
- vii. Are there any large corporations who would like to 'sponsor' any work to have their name associated to the project?
- viii. Are there new techniques to tiling the farm land to reduce the water dispersing into the Ditch 13?
- ix. How to change the regulations around tiling?
- x. Can ditch 13 be modified?
- xi. Can the vertical tiling be used in new urban development?
- xii. Diane indicated that EOR revised its engineering on the Sutton Lake project and with the permission of the DNR, may be able to substantially increase the storage capacity
